

# NEW AMENDMENTS TO THE REGULATIONS GIVING MONEY, FOOD, AND NECESSARY ITEMS TO INMATES AND DEFENDANTS (SUMMARY)

EFFECTIVE DATE: DECEMBER 19, 114

THIS AMENDMENT AIMS TO CLEARLY DEFINE THE SCOPE OF "EXTERNAL  
WORLD".

IT ALSO CLARIFIES THE RECIPIENTS AND PROCEDURES FOR DEPOSITING FUNDS AND  
PROTECTS THE RIGHTS OF DETAINEES.

# WHO IS 『OUTSIDE WORLD』 ? ( SENDER QUALIFICATION )

- 『OUTSIDE WORLD』 THIS REFERS TO INDIVIDUALS WHO CAN PROVIDE INMATES WITH MONEY, FOOD, AND NECESSITIES, AND INCLUDES THE FOLLOWING CATEGORIES:

1. THE DETAINEE'S CLOSEST RELATIVES (E.G., SPOUSE, PARENTS, LINEAL RELATIVES, SIBLINGS, ETC.).
2. FAMILY MEMBERS OF THE DETAINEE (FAMILY MEMBERS LIVING TOGETHER MUST SUBMIT A WRITTEN APPLICATION AND ATTACH PROOF OF COHABITATION).
3. THE PERSON WHOM THE ORGANIZATION DEEMS NECESSARY AND APPROPRIATE.
4. THE PERSON PROPOSED BY THE INMATE

 **【 Special Note: The person who proposes the detention. 】**

This could be someone who runs a catering business, a bookstore owner, a classmate, a friend, etc.

Inmates must submit a written application to the correctional authority.

No more than three individuals may apply.

Changes to the list also require a written application.

# 『OUTSIDE WORLD』 SEND MONEY TO THE DETAINEES

Method → In-person payment at the counter (cash)	<ul style="list-style-type: none"><li>○ The person delivering the item should bring cash to the reception desk for processing.</li></ul>	Please cooperate by presenting your identity documents.
Method → Mail delivery (cash bag, money order, etc.)	<ul style="list-style-type: none"><li>○ Please send the cash bag or bank draft/promissory note (issued by Chunghwa Post or a domestic financial institution) by registered mail to this agency.</li></ul>	Please be sure to specify the name and number of the detainee.
Number of times limit	Each person may deliver funds to an individual detainee limited to once per day.	Exception: This does not apply if permitted by the head of the organization. Please submit a written application in advance.
Amount limit	Each deposit is capped at NT\$10,000.	



## Helpful Reminder

Identity Verification: When processing transactions in person, please be sure to bring your identification documents that comply with external regulations, to facilitate verification by the authorities.

Funds processing: All money deposited will be deposited into the inmate's account so that they can purchase the items they need within the facility.

The detainee's closest relatives, family members, persons deemed necessary and appropriate by the authorities, and persons nominated by the detainee.

FOOD TYPE RESTRICTIONS (PLEASE DO NOT SEND THE WRONG ITEM)

<input checked="" type="checkbox"/> <b>Types that can be sent</b>	<input type="checkbox"/> <b>Types not accepted</b>
<ul style="list-style-type: none"> <li>◎ Staple food: Staple foods that do not require reheating (e.g., white rice, noodles, etc., but must meet inspection regulations).</li> <li>◎ Dishes: Dishes that are cooked and ready to eat without reheating.</li> <li>◎ Fruit: Fruit that can be eaten immediately.</li> <li>◎ Biscuits: All kinds of biscuits.</li> </ul>	<ul style="list-style-type: none"> <li>◎ Pastries: such as cakes, bread, mooncakes, etc.</li> <li>◎ Frozen, raw, or foods requiring heating before consumption.</li> <li>◎ Liquid or liquid foods such as soups, beverages, tea, and ice cream.</li> <li>◎ Other foods that cannot be inspected or have hygiene concerns.</li> </ul>

**⚠ Important principle: All food and drink delivered must be easily inspectable and free from any potential issues. Anything that fails inspection will be rejected by the authorities.**

MAXIMUM NUMBER OF SUBMISSIONS AND WEIGHT

Defendant	Limit once per day	Each time, the weight shall not exceed 2 kg.
victim	Limited to once every three days	Each time, the weight shall not exceed 2 kg.
<p>Each person sent in is limited to one person and one delivery per day.</p> <p>Exception: This restriction does not apply if the person sending the food is a close relative or family member of an inmate in the same facility. For example, a sister sending food to her two brothers serving time in the same facility.</p>

THE "METHOD" OF FOOD DELIVERY AND THE QUALIFICATIONS OF THE "DELIVERER".

<b>Feeding method</b>	They must be submitted at the time and place designated by the authorities (the registration office for visits) and undergo inspection.
<b>Sender (external) qualifications</b>	<ul style="list-style-type: none"> <li>◎ The detainee's closest relatives and family members</li> <li>◎ A person nominated by the detainee in writing (maximum three people)</li> </ul>

## NECESSARY ITEMS WERE SENT IN FROM THE OUTSIDE WORLD.

<b>Regulations for submitting necessary items</b>	Detainees applying for the delivery of necessary items from outside should fill out an application form and submit it to the relevant authority.
Apply for a project	The necessary items listed in Article 6, Paragraph 1 of these Measures (e.g., underwear, towels, books and magazines).
Other items	Other property listed in Article 6, Paragraph 4 of these Measures (e.g., assistive devices for the disabled, medicines that urgently need to be used).
Number of times limit	Limited to one application per month
Feeding method	<ol style="list-style-type: none"><li>1. By mail</li><li>2. By delivery at the time and place designated by the agency</li><li>3. By other methods permitted by the agency</li></ol>
Reminder: All submitted items must be inspected by the authorities. Please confirm in advance whether the items comply with regulations to avoid being returned.	

Once the detainee's application is approved, their relatives, family members, and designated close friends (up to three) are qualified to send money to the authorities.
